

## TAX CUTS

684,000 Nebraskans are benefitting from the Making Work Pay tax cut, putting a total of \$346 million into Nebraskans' pockets in 2009 and \$327 million in 2010<sup>1,2</sup>. The Making Work Pay tax cut put more than **\$98.5 million** back into the economy of Douglas County in 2009 and **\$93 million** in 2010<sup>3</sup>.



## EDUCATION

Douglas County's school districts were saved from making further cuts to their budgets through the use of over **\$122.3 million** in Recovery Act funds, including<sup>4</sup>:





\$220 Million in Recovery Funds in Nebraska




## FIRST TIME HOMEBUYER CREDIT
